1. This Request for Quotation follows the General Procurement Notice for this Project that appeared in *Development Business*, with **Reference No. AFDB80-05/12** posted **11th May 2012**.

The Government of Liberia received a grant from the Global Agriculture and Food Security Program (GAFSP) and a loan from the African Development Fund toward reducing rural poverty and household food insecurity by increasing income for smallholder farmers and rural entrepreneurs particularly women, youths and the physically challenged. The Government of Liberia intends to apply part of the proceeds to payments under the Contract for the **Transportation of Rice Milling Equipment to Grand Gedeh, River Gee, Maryland and Grand Kru Counties.
